# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to soulfulodyssey.com, and Wynning Ways, Inc and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Wynning Ways, Inc include soulfulodyssey.com and Soulful Odyssey. The Soulful Odyssey website is a travel consultant services site. By using the Soulful Odyssey website, you consent to the data practices described in this statement.

## California Consumer Privacy Act and California Privacy Rights Act

If you are a California resident, you have the following rights under the California Consumer Privacy Act ("CCPA") and California Privacy Rights Act ("CPRA"):

- **Right to Know.** You may request details on what personal data we collect, use, and share.
- **Right to Delete.** You can request deletion of personal data, subject to certain legal exceptions.

## **Collection of your Personal Information**

# **Sharing Information with Third Parties**

# **Security of your Personal Information**

#### - SSL Protocol

- ï Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- ï Comply with the California Electronic Communications Privacy Act;
- ï Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- ï Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- ï Comply with an existing legal obligation; or
- i Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

#### **Children Under Thirteen**

Soulful Odyssey does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
